SHEIKH TALEB GIVES EVIDENCE

Counsel Demands Citation Of Palestine Bulletin For Contempt

When the case against Sheikh Taleb Marka, who is charged with being responsible for the Hebron outbreak, was to have been resumed yesterday it was found that prosecuting counsel was not present The case could not therefore be proceeded with and it was adjourned for some time.

The most striking event in the day's hearing was the evidence of the prisoner himself.

POLICE OFFICER'S EVIDENCE

During the course of the trial a Police Officer gave evidence to the effect that he went round to the Jewish houses in Hebron on Saturday morning. He ordered the Jews to remain in their houses, to lock their doors and to keep all their windows tightly shut.

Counsel for the Defence: "What did that order mean?"

Judge to Counsel: "What do you think it means?" The Court would not allow a re-cross-examination of Mazal Mizrachi on the ground that the full cross examination had already taken place.

There was a moving scene when a widow, whose husband and son had been murdered in Hebron, gave evidence. She said that after her husband and her son had been done to death by the excited mob, the prisoner urged the crowd to kill her also.

The woman appeared in Court swathed in bandages. Her evidence was punctuated with bobs. Counsel for the Defence gave her a long and critical cross-examination.

A man who was in the Slonim building at the time when the butchery occured there, was called as a witness. He explained that his own life was saved because he lay under a heap of dead bodies. Two people had been killed in his own house, he said, and therefore he had taken refuge in the house of Slonim.

Prisoner's Evidence

The prisoner, having been sworn, gave evidence. He said that he did everything possible to passify the crowd on Friday. On the following day he was not present at all. "On Friday I was in the shop of Solom ben Hayim, when I heard a boy cutside shouting and trying to create trouble. I went out to give the boy a good thrashing. reported the matter to the Police. When I returned, I found the crowd excited about the supposed riots which had taken place in Jerusalem. I tried to dissuade the crowd from believing the stories that they had heard. I did not incite the crowds to riot. I am not in the habit of making speeches. After the crowd had dispersed and Assistart Superintendent Cafferata appeared on the scene, everything was quiet."

In reply to a question as to whether he knew about the murders of the students in the Jewish College, the prisoner replied that he did know about those murders. He did not think that conditions in Hebron were abnormal. On Friday he did not leave his house. On Saturday morning he

In reply to questions put to the prisoner by the Court, Sheikh Taleb Markah said that he was a

friend of the Jews. Mr. Justice Corrie: "Why do people who are friends of your's charge you with instigating?"

The prisoner: "The story is an invention of out siders not of Hebron Jews. No Moslem leaders support the idea of riots."

It was pointed out to the prisoner that his testimony did not agree with that of Assistant Superintendent Cafferata, and he was asked whether that witness was not telling the touth.

The prisoner gave evidence to the effect that on Friday he saw a car carrying twenty Moslems with swords which was bound for Jerusalem. The prisoner says that he dissuadeed then from procceding, but Superintendent Cafferata told them they might go on. This incident, said the prisoner, was curiously enough not included in the evidence given by Assistant Superintendent Cafferata. The Sheikh added that the Jews of Hebron were extremely grateful to him for what he had done. Mr. Justice De Freitas: "Why did you, an Elder and a member of the Arab Executive, hide yourself in a shop at the time when there was great unrest and danger? Why did you not go to the District Officer, and why did you make no attempts to do anything at all on that morning? Did you realize that there was a great responsibility laid upon you?"

The prisoner, when he had answered a question, looked each time towards his counsel. The Court requested him to look at the Judges when answer-

THE PALESTINE BULLETIN CRITICISED IN COURT

When the afternoon session on the previous day was opened, Counsel for the Defence made ar application to the Court that the Palestine Bulletin be cited for contempt of court on the alleged ground that the Palestine Bulletin had referred to Asst. Superintendent Cafferata's evidence as "wonderful" which is a term which might prejudice the Court and also on the ground that the prisoner had been referred to as a ringleader and not as the alleged ringleader.

The Court failed to find the word "wonderful" in the Palestine Bulletin (the word was not used) and therefore could not arrest the editor of the Palestine Bulletin on that score.

With regard to the word "alleged" which was alleged to have been omitted in a headline, His Honour pointed out that newspapers often omit the word. At the same time he advised resposible editors to use the word more in future when a prisoner has not been convicted.

Lord Allenby Regrets Destruction Of Melnikoff's Studio

Lord Allenby was very sorry to hear of the attack on Mr. Melnikoff's studio when informed of it He recalled that he sat for the artist for his statue which was erected by the Palestine Government at Beersheba and referred to Mr. Melnikoff as a great artist and a good Palestinian.

Lord Allenby said to a representative of the '-Palestine Bulletin' in London:

"I am sorry to hear of the attack on Mr, Melni-"koff's studio. I had the honour of sitting for "him and I consider him a great artist and a "good Palestinian."

Lord Allenby added that it was impossible for him to make a statement on the general situation in Palestine.

It will be remembered that Melnikoff was working on the memorial in Metullah at the time of the riots. On his return to Jerusalem he found his studio in ruins and the work of years smashed to pieces.

Herbert Samuel On Relations Between Jews and Arabs

LONDON, October 17 (P.T.A.)

"If we were but lead by our intelligence and not by our emotions, we would be forced to realise and to remember that when two races live in the same land they must find means of living peaceably together. It is the duty of thoughtful men of both races to adopt such measures as will promote reconciliation and good fellowship among the people. This end can perhaps best be brought about by the Hebrew University." These memorable words were spoken by Sir Herbert Samuel, ex-High Commissioner of Palestine, at a meeting of the Friends of the Hebrew University here todya. At the same meeting Lord Melchett said that enlightenment emanating from Mount Scopus would matrially help to improve the relations bewteen Jews and Arabs. Jewish educational institutions in Palestine were always opened to Arabs, he said. The Jews always worked for the benefit of the entire community.

If The Jews Left Palestine

Were the Jews to leave Palestine, Lord Melchett aid, the Palestine Administration would go bankupt. Higher education would cease. Agricultural development would not progress. Commerce would dwindle. Industry would die out. The country would return to that deplorable state under which it was when the British Administration rescued it from the hands of the Turks.

CONTRADICTORY EVIDENCE IN CASE AGAINST PERSIAN DEWS

3 Jews were yesterday brought before the Examining Magistrate, Mr. Camp, on a charge of burning and looting. The complainant, an Arab, had a house in the Bukharian quarter. He gave evidence that he saw smoke coming from his house from a distance, and saw a Persian Jew carrying sacks out of his house to the house of the first accused. The complainant saw the second and third prisoners carrying sacks on their backs from his own house to their houses. The witness also said that he could see all these things from a distance which is about equal to that from the Court to the Post Office. He could even describe the colours of the clothes which the accused wore at that time. The daughter of the previous witness gave evidence and corraborated her father, but she said that they left their house on Saturday-the birthday of the Prophet-while her father alleged that they left it on Tuesday before the riots. The case is adjourned till today.

LORD TOMSON AND R 101 Proposed Flight To India

Lord Thomson, Secretary for Air, hopes to make a flight to India in the airship R 101, if his public engagements permit. Until the home trials of the airship are completed, however, the date cannot be arranged.

The airship was not brought from her shed at Cardington vesterday, owing to the prospect of unhavourable weather.

LABOUR TRIUMPH IN AUSTRALIA What It Means For World Peace

MELBOURNE, Thursday (P.T.A.-R.) Mr. Scullin, interviewed by Reuter, said that the fact that Labour was ruling simultaneously in England and Australia would prove most beneficial to both countries and would materially assist in grappling with matters of mutual concern. Australian Labour, he said, would work in harmony with Great Britain in peaceful overtures to America and other countries, and would most heartily support Great Britain's practical steps for a reduction of armaments, which he hoped would lead to universal disarmamet and world peace. The Labour party when it took over the reins of Government would conscientiously work to carry out its established programme.

LEADER OF JUGOSLAVIAN SOCIETY TO BE SHOT

ROME, October 17 (B.T.I.O.) The case against Vladimir Goten, the leader of the Jugoslavian Society, which, as was reported in The Palestine Bulletin, is attempting to wrest the provinces of Istria from Italy, has been found guilty of attempting to start a terrorist revolt against Italy, and has been ordered to be shot. He is asking that the prerogative of mercy should be exercised in his favour. Four of his accomplices has been sentenced to 30 years' imprisonment.

A STORM IN A ROYAL TEA-CUP

BERLIN, Thursday. - Messages from Bucharest say that a sensation was caused in the country by an episode during the Regency crisis. According to the newspapers, Queen Marie intimated her desire to join the Rogency Council, and the Government agreed provided Prince Nicholas resigned. The Queen retorted vigorously refusing to consider such "paltry bargaining" and pointing out that she was actuated solely by the desire to give Prince Nicholas advisory support and not to gain a predominating role on the Council for the royal family.

Government circles declare that the attitude of the Dowager Queen is unprecedented and that Parliament has been insulted by a member of the royal family not holding an official position, and that more is likely to be heard of the incident.

BERLIN, Friday. - Further messages from Bucharest state that the original proposal for Queen Marie to join the Regency Council emanated from the Premier, M. Maniu and not from Queen Marie herself.

The newspaper "Universal" states that following the death of Doctor Buzdugan the Government indirectly suggested that Queen Marie should replace Prince Nicholas and as compensation that she should nominate a further 'wo members to the Council.
